RE: Woodville ATE – Loan Note Report

I am pleased to confirm that between the 1st of October 2025 and the 31st of October 2025, **Woodville Consultants Ltd transferred 1,296 coupon payments to Investors.**

All coupons have been paid on time with **Zero Defaults** since inception.

There was a total of 163 maturing investments during the same period. 78 were returned to investors in full, and 85 were reinvested.

We are pleased to report that Woodville received a total of 126 new investments.
