The ratings range from 1 to 5 globes - the higher number of globes, the lower the ESG risk - meaning they are well equipped to manage environmental, social and governance challenges. The Hansard International Fund range includes a number of underlying funds that score the highest rating (5 globes) and are listed in the table below.
