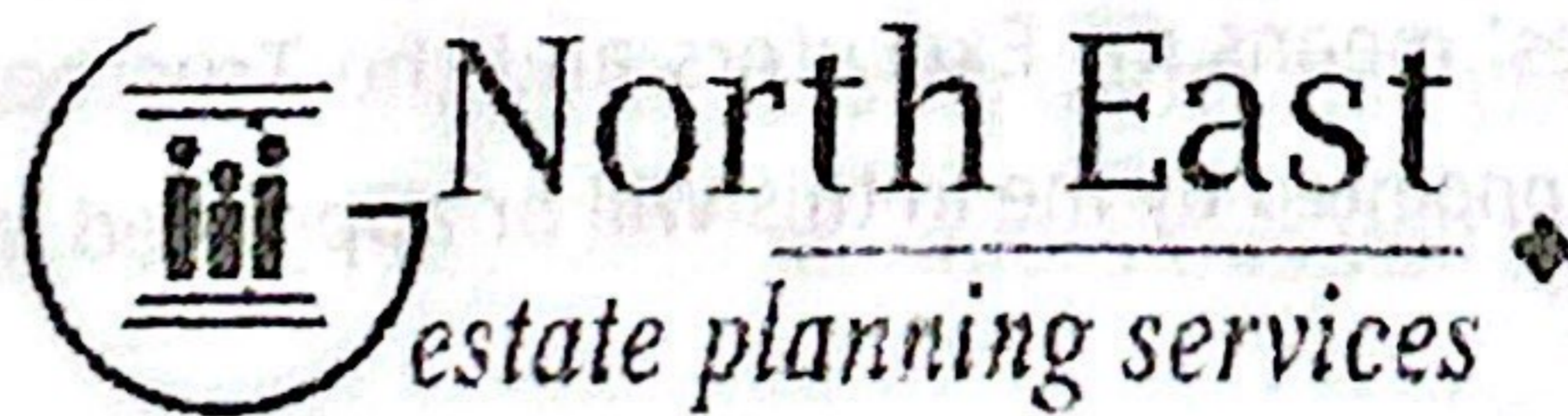

This is the Will of **Miss Christine Rutherford** of 17 Garner Close, Newcastle upon Tyne, Tyne and Wear, NE5 1SQ, born on the 19th of February 1957.

**1. Revoking Previous Wills**

This is my last Will. It replaces and revokes any earlier Wills I have made.

**2. Funeral Arrangements**

I wish for my body to be cremated, and I would like a church service with a vicar and guests to wear bright colours. I would also like the record played at the end of my funeral I've had the time of my life by Bill Medley and Jennifer Warnes.

**3. Organ Donation**

I wish my body and all of my organs to be available for organ donation and therapeutic purposes.

**4. Appointment of Executors and Trustees**

4.1. I appoint my cousin **Miss Kirsten Jane Howorth** of 8 Irwin Avenue, Wallsend, Tyne and Wear, NE28 7QX, born on the 27th of September, 1972 to be my sole Executor and Trustee.

4.1.1. My Executors shall have the power to access, use, distribute and dispose of my digital devices and digital assets, software, licences and accounts, including financial accounts, wherever or however stored, as they think fit giving due consideration to any letter of wishes I may prepare unless no such letter has been left by me to cover specific digital assets, in which case they will pass under my residual estate.

4.2. In the rest of this Will, 'Trustees' means my Executors and the Trustees of any trust created under this Will, either appointed by me in this Will or appointed later under the terms of a trust.

**5. Gifts of Money**

5.1. I give **£10,000** free of any inheritance tax to my Great nephew **Mr Oliver George Lyon** of 135 Sunset Wasn #07-10, Clementi Park 5597158, Singapore, born on the 16th of September, 2007 at the age of 21. If my Great nephew **Mr Oliver George Lyon** has predeceased me, or his gift should fail, his gift shall pass equally to his own children at

the age of 21, but if any children at the age of 21.

5.2. I give **£10,000** free of any inheritance tax to my Great nephew **Mr Oliver George Lyon** of 135 Sunset Wasn #07-10, Clementi Park 5597158, Singapore, born on the 16th of September, 2007 at the age of 21. If my Great nephew **Mr Oliver George Lyon** has predeceased me, or his gift should fail, his gift shall pass equally to his own children at the age of 21, but if any children at the age of 21.

**Gifts of Personal Possessions**

In this clause, what I refer to is the personal possessions given in section 3(1) of the Will. I wish to distribute them in accordance with my wishes and pay any inheritance tax.

**Definition of Estate**

My estate shall mean all my personal possessions.

**Administration of My Estate**

My Executors may sell any of my personal possessions if appropriate and then shall distribute the proceeds in accordance with my wishes.

8.1. To pay my debts and funeral expenses.

8.2. To pay any tax or duty payable on my death or on any gifts made by me.

8.3. My Trustees shall hold the residue of my estate (my Residuary Estate) for the following purposes:

8.3.1. 12.5% to my Great nephew **Mr Oliver George Lyon** of 135 Sunset Wasn #07-10, Clementi Park 5597158, Singapore, born on the 16th of September, 2007 at the age of 21. If my Great nephew **Mr Oliver George Lyon** has predeceased me, or his gift should fail, his gift shall pass equally to his own children at the age of 21, but if any children at the age of 21.

5.2. I give **£10,000** free of any inheritance tax to my great nephew **Mr Charlie Alexander Lyon** of 135 Sunset Wasn #07-10, Clementi Park 5597158, Singapore, born on the 11th of October, 2011 at the age of 21. If my great nephew **Mr Charlie Alexander Lyon** has predeceased me, or his gift should fail, his gift shall pass equally to his own children at the age of 21, but if any such child is unable to benefit, their gift shall pass to their own children at the age of 21.

### **Gifts of Personal Possessions**

In this clause, what I refer to as "personal possessions" (personal chattels) has the meaning given in section 3(1) of the Inheritance and Trustees' Powers Act 2014. I give my personal possessions, not otherwise dealt with by this Will to my Executors with a request they distribute them in accordance with any wishes of mine that come to their attention free of any inheritance tax.

### **Definition of Estate**

My estate shall mean all my legal and beneficial interests in property, money and possessions.

### **Administration of My Estate**

My Executors may sell or convert any or all of the remaining assets as they consider appropriate and then shall hold my estate in trust on the following terms:

- 8.1. To pay my debts and any funeral costs, executor costs or administration expenses.
- 8.2. To pay any tax or duty relating to assets passing under this Will or due as a result of my death on any gifts I made during my lifetime, unless this Will specifies otherwise.
- 8.3. My Trustees shall hold whatever remains, including any income earned after my death ("my Residuary Estate") on the trusts set out below:

8.3.1. **12.5%** to my niece **Mrs Lucy Elizabeth Lyon** of 135 Sunset Wasn #07-10, Clementi Park 5597158, Singapore, born on the 13th of February, 1976. If my niece **Mrs Lucy Elizabeth Lyon** has predeceased me, or her gift should fail, her gift shall pass equally to her own children at the age of 21, but if any such child is unable to benefit, their gift shall pass to their own children at the age of 21.

8.3.2. 12.5% to my Nephew **Mr Tom William Rutherford** of 4 Frances Stn Unit 8, Bendi Beach NSW, Australia 2026, born on the 6th of May, 1982 at the age of 21. If my Nephew **Mr Tom William Rutherford** has predeceased me, or his gift should fail, his gift shall pass equally to his own children at the age of 21, but if any such child is unable to benefit, their gift shall pass to their own children at the age of 21.
